

Jonathan Gaylord Scholarship Application

The Jonathan Gaylord Scholarship Fund was established in 1972 to memorialize the life of Jonathan Gaylord, son of Reverend Raymond and Jeannette Gaylord. The primary objective of this scholarship fund is to assist ministerial students from Cascade Christian Church who have demonstrated a need for financial aid. Such students will receive priority in the allocation of available funds. The Scholarship Fund also provides assistance, however, to high school graduates and college students from Cascade Christian Church who are preparing for careers in service vocations, such as nursing, medicine, teaching and social work. The Fund will also consider applications of college students from Cascade Christian Church who are considering careers in other fields of study. All colleges and seminaries must be fully-accredited and approved by the Gifts and Endowments Committee.

Funds for the scholarship are derived from interest on invested funds and, in part, from gifts given to the church specifically for the Fund. Therefore, the amount available for scholarships may vary from year to year. Consequently, the amount of each award shall be determined by the funds available at the time aid is sought and the priorities listed above.

Scholarship recipients are selected by the Gifts and Endowments Committee. Each applicant will complete a written application, provide relevant grade transcripts and be willing to submit to a personal interview, should the committee deem it necessary. The scholarship may be renewable upon evidence that the student is making satisfactory progress in the chosen field of study.

Interested persons should submit the written application and required attachments no later than October 1st of the year for which aid is requested. Funds will be disbursed at, or shortly before, the beginning of the calendar year. Application forms are available from the church office and on-line at the Cascade Christian Church website.
